This matter came on for consideration at a prehearing conference (hereinafter "conference") pursuant to 21 N.C.A.C. 46 .2008 on September 25, 2006. Board President Rebecca Chater presided. Also present at the conference were the following:

- Josh Kohler, Assistant Director of Investigations & Inspections;
- Karen Matthew, Director of Investigations & Inspections;
- Anna Baird Choi, Counsel for the Board;
- George Davis, owner of New Bern Medical Arts Pharmacy (Respondent Pharmacy); and
- Cynthia Burrows, RPh. (Respondent Burrows).

Wilbur Crumpler, RPh. (Respondent Crumpler) was also served with a Notice of Prehearing Conference. However, he was not present at the Conference. Based upon the record in this proceeding and the statements and materials presented at the conference, the Board makes the following:

## FINDINGS OF FACT

 Respondent Burrows is licensed to practice pharmacy by the Board and is the holder of license number 8195. At all relevant times, Respondent Burrows was employed as the Pharmacist Manager at Respondent Pharmacy located at 1916 Neuse Road, New Bern, North Carolina

- 2. Respondent Crumpler is licensed to practice pharmacy by the Board and is the holder of license number 4070. At all relevant times, Respondent Crumpler was employed as a staff Pharmacist at Respondent Pharmacy located at 1916 Neuse Road, New Bern, North Carolina.
- 3. On July 29, 2005, the Board received a complaint from a physician who called on behalf of a patient. The physician alleged that the pharmacy dispensed Morphine Elixir 10mg/5ml on a prescription order for Morphine Elixir 10mg/15ml. Morphine is a schedule II controlled substance.
- 4. The investigation produced evidence to show that on or about May 25, 2005, Respondent Crumpler dispensed Morphine Elixir 10mg/5ml on a prescription order for Morphine Elixir 10mg/15ml.
- 5. The investigation produced evidence to show that on or about June 20, 2005, Respondent Burrows dispensed Morphine Elixir 10mg/5ml on a prescription order for Morphine Elixir 10mg/15ml.
- 6. During an interview conducted on January 4, 2006, Respondent Burrows informed Mr. Kohler that she misread the prescription on her final check of the medication because she was accustomed to the patient receiving Morphine Elixir 10mg/15ml.
- 7. At the Prehearing Conference, Ms. Burrows stated that the patient was unaware that the strength of the medication had been decreased and that she thought the physician had made an error on the prescription.
- 8. The investigation produced evidence to show that though the patient signed the counsel logs on May 25 and June 20, 2006, the pharmacy had no documentation of acceptance or refusal of patient counseling.

9. No evidence was presented to show that the patient suffered any long-term side effects.

Based on the above findings, the Board concludes as a matter of law:

## CONCLUSIONS OF LAW

- Respondent Burrows admits that the conduct in this matter constitutes sufficient grounds for disciplinary action on her license under G.S. 90-85.38.
- Respondent Crumpler admits that the conduct in this matter constitutes sufficient grounds for disciplinary action on his license under G.S. 90-85.38.
- Respondent Pharmacy admits that the conduct in this matter constitutes sufficient grounds for disciplinary action on its permit under G.S. 90-85.38.
- 4. Respondents violated the following statutes and rules when they dispensed and delivered the incorrect strength of Morphine Elixir to a patient and failed to document the patient's acceptance/refusal of counseling:
  - a. G.S. 90-85.38(a)(6), (7) and (9);
  - b. G.S. 90-85.40;
  - c. G.S. 90-106;
  - d. G.S. 90-108;
  - e. G.S. 106-134.1;
  - f. 21 N.C.A.C. 46 .1805;
  - g. 21 N.C.A.C. 46 .2504;
  - h. 21 U.S.C. 352; and
  - i. 21 CFR 1306.11.

- 5. Additionally, Respondent Burrows and Respondent Pharmacy violated the following rule when the incorrect strength of Morphine Elixir was dispensed and delivered to a patient:
  - a. 21 N.C.A.C. 46 .1804.

Based on the foregoing, and with the consent of the parties, IT IS THEREFORE, ORDERED, as follows:

- 1. Respondent Burrows, license number 8195, is hereby warned.
- Respondent Crumpler, license number 4070, is hereby warned.
- 3. Respondent Pharmacy, permit number 2704, is hereby warned.
- 4. Respondents shall cooperate with the Board, its attorneys, investigators, and other representatives in any investigation of their practice and compliance with the provisions of this Consent Order.
- Respondents shall violate no laws governing the practice of pharmacy or the distribution of drugs.
- Respondents shall violate no rules and regulations of the Board.
- If Respondents fail to comply with any terms or conditions of this Consent Order,
   Respondents may be subject to additional disciplinary action by the Board.
