THIS MATTER came on for consideration at a prehearing conference (hereinafter, "conference") pursuant to 21 N.C.A.C. 46.2008. This conference was scheduled for March 18, 2013, and, after appropriate notice, was heard on that day at the office of the North Carolina Board of Pharmacy (hereinafter, "Board") by Board member Dr. J. Parker Chesson, Jr. Respondent Lori Champion Melton ("Melton") and her counsel, James A. Wilson, were informed of their right to be present at the conference, in person, and waived that right. Board Counsel Clinton R. Pinyan and members of the Board's investigative and legal staff were present at this conference.

FINDINGS OF FACT

- 1. Respondent Lori Champion Melton holds technician registration 1622. At all relevant times, Respondent Melton was a technician at Tayloe's Hospital Pharmacy, 601 East 12th Street, Washington, NC 27889 (Permit No. 01809).
- 2. On April 10, 2012, Respondent Melton was charged by a grand jury in the United States District Court for the Eastern District of North Carolina with felony counts related to obtaining hydrocodone, clonazepam and propoxyphene by misrepresentation, fraud and deception.
- 3. On May 15, 2012, the Board summarily suspended Respondent Melton's registration as a pharmacy technician.

- 4. On January 23, 2013, the United States Attorney dismissed all of the charges against Respondent Melton.
 - 5. Respondent Melton has requested termination of the summary suspension.

CONCLUSIONS OF LAW

In order to resolve the request for termination of the summary suspension, the Board finds and concludes that it is appropriate to grant the request for termination of the summary suspension. This conclusion is made solely to resolve the request for termination of the summary suspension.

Based upon the foregoing, and with the consent of the parties, IT IS THEREFORE ORDERED that the request for termination of the summary suspension of Respondent Melton's registration, Technician Registration No. 1622, is GRANTED. The summary suspension of Respondent Melton's registration is terminated without prejudice to the authority of the Board to institute a disciplinary proceeding against Respondent Melton at a later date. In the event that any such disciplinary proceeding is instituted, this Consent Order shall not constitute an admission, finding or conclusion about the merits of any such proceeding by any party, nor about any discipline that might or might not be appropriate.
