THIS MATTER came on for consideration at a prehearing conference (hereinafter, "conference") pursuant to 21 N.C.A.C. 46.2008. This conference was scheduled for September 12, 2016, and, after appropriate notice, was heard on that day at the office of the North Carolina Board of Pharmacy (hereinafter, "Board") by Board member Gene Minton. Board Counsel and members of the Board's investigative and legal staff were present at this conference. Medaus, Inc. ("Medaus" or "Respondent") was informed of its right to have representatives present at the conference, in person, and waived that right.

FINDINGS OF FACT

- 1. Medaus operates a pharmacy located at 6801 Cahaba Valley Road, Suite 116, Birmingham, Alabama 35242. On August 2, 2004, Medaus was granted out-of-state pharmacy permit 8786 by the Board.
- 2. On July 1, 2016, the Alabama pharmacy permit of Medaus was disciplined by a final order of the Alabama Board of Pharmacy (the "Final Order").
- 3. Paragraph (a) of the Final Order made findings of violations of Alabama and federal law with respect to Medaus's sterile compounding operations. That paragraph of the Final Order is incorporated herein by reference.
- 5. Among other discipline, the Final Order prohibits Medaus from engaging in any sterile compounding until permitted by the Alabama Board upon a petition from Medaus (which

may come no sooner than July 1, 2018), and prohibits Medaus from engaging in office-use compounding.

CONCLUSIONS OF LAW

Based on the above findings, the Board concludes as a matter of law:

- 1. Respondent Medaus, Inc., violated North Carolina General Statutes Section § 90-85.38(b).
- 2. Respondent admits that the conduct in this matter constitutes sufficient grounds for disciplinary action on its permit under N.C. Gen. Stat. § 90-85.38.

Based upon the foregoing, and with the consent of the parties, IT IS THEREFORE ORDERED that the permit of Respondent Medaus, Inc., is hereby REPRIMANDED. In addition, the following restrictions are placed upon the permit of Respondent Medaus, Inc.:

- 1. Respondent shall not engage in sterile compounding or dispensing any sterile drug products, excluding those dispensed in manufacturer's original packaging, until expressly permitted by order of the Alabama Board of Pharmacy, and, in no event, shall Respondent engage in any sterile compounding or dispensing any sterile drug products until at least July 1, 2018;
- 2. Respondent may dispense drugs only on patient-specific prescriptions, both domestically and internationally;
- 3. Respondent shall cooperate with the Board, its attorneys, investigators and other representatives in any investigation and compliance with the provisions of this Consent Order;

- 4. Respondent shall violate no laws governing the practice of pharmacy or the distribution of devices or medical equipment;
 - 5. Respondent shall violate no rules and regulations of the Board; and
- 6. Respondent shall maintain full compliance with both this Consent Order and the Alabama Final Order.

If Respondent fails to comply with any terms or conditions of this Order, Respondent may be subject to additional disciplinary action by the Board.
