

**BEFORE THE NORTH CAROLINA BOARD OF PHARMACY**

**THIS MATTER** came on for hearing upon the request of June Kelli Barker (Petitioner) for reinstatement of her license to practice pharmacy in North Carolina. Petitioner's request was heard by the Board on June 17, 2003, at the North Board of Pharmacy (Board) meeting held at The Hampton Inn, 6121 Farrington Road, Chapel Hill, North Carolina. Based upon the record in this proceeding and the testimony and other materials of record presented at the hearing, the Board makes the following:

**FINDING OF FACT**

1. Petitioner was licensed to practice pharmacy by the Board on July 25, 1995, and was the holder of license number 12966.
2. By Order dated June 19, 2002, the Board summarily suspended Petitioner's license to practice pharmacy based upon Petitioner obtaining, consuming and dispensing legend prescription drugs and controlled substances without authorization and in violation of State and Federal statutes and regulations.
3. On June 12, 2002, Petitioner was charged criminally with (Larceny) a Class H or I felony and pled guilty. Upon entry of the plea Petitioner was granted by the court deferred prosecution for a period of one year and upon all conditions being met the State would take a voluntary dismissal with leave.

4. Petitioner met with then Executive Director of the North Carolina Pharmacist Recovery Network (NCPRN) David Marley in July of 2002 and entered into a PRN contract through July 1, 2007.
5. Petitioner attends five recovery meetings per week and works with an AA sponsor.

#### **CONCLUSION OF LAW**

Petitioner has demonstrated that she has been in a period of successful recovery and compliance with her PRN contract. The Board, in its discretion concludes that Petitioner can safely resume the practice of pharmacy, subject to the conditions set forth below.

**IT IS THEREFORE, ORDERED** that Petitioner's license to practice pharmacy shall be reinstated, subject to the following conditions:

1. Petitioner's pharmacy license number 12966, is reinstated today June, 17, 2003.
2. Petitioner shall not serve as pharmacist manager of any pharmacy.
3. Petitioner shall not serve as a preceptor of pharmacy students.
4. Petitioner shall obtain prior approval by the Board's Executive Director of her employment as a pharmacist in North Carolina.
5. Petitioner shall successfully complete her PRN contract.
6. The Board recommends that following completion of the PRN contract the Petitioner continue to have an ongoing relationship with PRN.

7. Petitioner shall write a brief report on the meeting with the South Carolina Board of Pharmacy and send it to the Executive Director of the North Carolina Board of Pharmacy showing that all issues have been resolved regarding her licensure status in that state.
8. Petitioner shall submit documentation that some portion of the required 10 hours of continuing education credits is in the area of addiction.
9. Petitioner shall violate no laws governing the practice of pharmacy or the distribution of drugs.
10. Petitioner shall violate no rules or regulations of the Board.
