In addition to the completion of the NC Board of Pharmacy Application, candidates should register online for the NAPLEX and MPJE Exams at <https://nabp.pharmacy/>.

**APPROVAL FOR NAPLEX & MPJE EXAMS**

Candidates are approved for the NAPLEX and MPJE exams on a daily basis by the North Carolina Board of Pharmacy. The Board does not approve any candidate for examinations until we have received your Certificate of Graduation certifying your graduation and at least 1500 internship hours, and a complete NC Application for Exam. Once the Board of Pharmacy has approved you for the exam(s), an ATT (Authorization to Test) will be emailed to you by Pearson VUE. **CHECK EXAM RESULTS ONLINE:**

Candidates may check **NAPLEX and MPJE Exam** results online by logging into the [Gateway](#). You should also report physical and email address changes at this site. Candidates can expect grades to be posted on the Gateway 3-5 business days after taking the exam. The minimum passing score for the NAPLEX and MPJE is 75.

**NOTIFICATION OF EXAM RESULTS/LICENSURE:**

Candidates will be notified by email of licensure upon successful completion of ALL exams. **Candidates will be licensed on Thursday of each week and may check for verification of licensure online at [www.ncbop.org](http://www.ncbop.org) by choosing "Verify a License", selecting "Pharmacist", then entering your name.** New license numbers are usually issued by noon each Thursday.
