

President Keith Vance called the meeting to order at 10:03 am with Board Members Ashley Duggins, Robert J. (Joey) McLaughlin Jr., Wallace Nelson, and Chris Sain present.

Ethics Statement & Welcome

President Vance read the Ethics Statement regarding conflicts of interest. No conflicts were noted by Board members.

Consideration of Meeting Minutes

The members received the July meeting minutes for review prior to the meeting. Mr. McLaughlin moved to approve. Ms. Corbin seconded. The motion passed unanimously.

Financial Reports

JP Brown presented the July and August monthly financial report. The members received the report prior to this meeting. The members reviewed and had no questions.

Process for Review and Approval of FY 2024-2025 Financial Audit (Campbell)

Each year, no later than October 31, the Board is required to file an annual report concerning its previous fiscal year. That annual report must include a copy of the previous fiscal year's financial audit report.

Our auditors completed field work for the FY 2024-2025 financial audit the last week of August 2025. The audit report is still in process.

To ensure that the annual report is timely filed by October 31 and includes the required financial audit report, staff recommends that – as in previous years – the Board delegate to the Budget and Finance Committee the responsibility and authority to review the financial audit report on behalf of the full Board. The B&F Committee can meet during the October 14, 2025 committee workday to do so.

Dr. Duggins moved to authorize the Budget & Finance Committee to review and accept the FY 2024-2025 audit report on behalf of the full Board. Mr. Nelson seconded. The motion passed unanimously.

Licensing Report (*Campbell*)

Pharmacy Intern Renewal Report

Mr. Campbell reported on behalf of Director of Licensing Missy Betz. The third pharmacy intern renewal season went smoothly.

2026 Renewal Update

Mr. Campbell reminded the Board that the renewal period for license/permit/registration begins on November 1st. There are no major changes in the process this year.

Investigations and Inspections Report

Director of Inspections Krystal Stefanyk presented the investigations report and current caseload.

Report on Joint Pharmacy-Nursing Board Webinar on State Law Governing IV Hydration Clinics (*Stefanyk*)

The first ever joint Pharmacy-Nursing Board Webinar was held on Thursday, September 4, 2025. The purpose was to increase the knowledge and understanding of the legal scope of practice and responsibilities of nurses and how these apply to the IV Hydration setting, as well as pertinent laws and rules pertaining to sterile drug compounding and IV infusion. Mrs. Stefanyk said that we hope to have many more successful collaborations with the Board of Nursing.

Third Annual Compounding Summit (*Stefanyk*)

Planning is underway for the 3rd annual Compounding Summit to be held at the Friday Center on February 24 – 26, 2026. Registration will begin on Oct. 1, 2025. Board members wanting to attend should contact Mrs. Stefanyk or Ms. Wilson.

Board member Mischelle Corbin joined the meeting at 10:30 am.

Legislative Report (*Pinyan, Campbell*)

Mr. Pinyan and Mr. Campbell provided the members with updates on various filed bills that could impact pharmacy practice regulation.

COVID Vaccine Administration Authority Update (Campbell)

On September 12, 2025, State Health Director Larry Greenblatt issued standing orders that pharmacists may deploy to satisfy the prescription requirement for administering COVID vaccine to patients age 18 and up who wish to receive it. Dr. Greenblatt's standing order bridged the challenge presented by the delay in ACIP recommendation. In light of ACIP recommendations becoming effective, Dr. Greenblatt's order will sunset on Monday, October 13, 2025. Pharmacies may continue to use the order until that date while making any necessary adjustments to their protocols or procedures for COVID vaccine administration. Once the standing order sunsets, pharmacists may continue to administer COVID-19 vaccine to patients who present a prescription from a provider.

The Board then took a short break and reconvened at 11:13 am.

Rulemaking Report (Pinyan, Campbell)Rulemakings Underway/Recently Completed

For Action by the Board:

Periodic Review and Expiration of Existing Rules (Pinyan, Campbell)

At the Board's July meeting, it voted to endorse the committee's recommendations and publish the proposed designations for notice and comment.

The designations were published for notice and comment for the statutorily required period of time, with the comment period closing on September 11, 2025. Board staff received no comments on the proposed designations.

Mr. Nelson motioned to approve the rule designations and direct Board Counsel Pinyan to transmit to the Rules Review Commission. Dr. Duggins seconded the motion. There were no dissenting votes.

Proposed Amendments to 21 NCAC 46.1418, Health System Technicians (Campbell, Pinyan)

The Board discussed the proposed amendments. Ms. Corbin moved to publish the amendments for notice and comment and was seconded by Mr. McLaughlin. The vote was unanimous.
